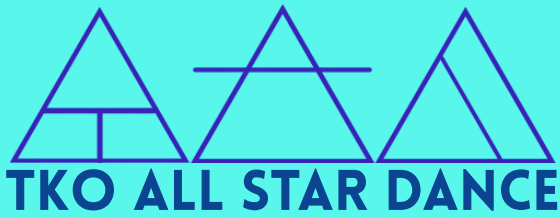

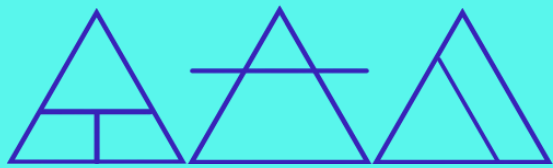

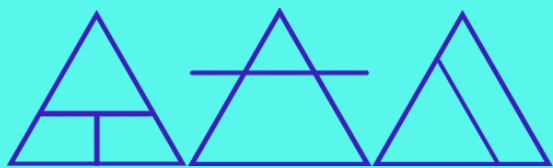
## HEALTH LIABILITY WAIVER
